Vision 20/20. Her overall take on it was that it had already begun to produce results, such as passed legislation easing teacher license transferrals from other states, and will continue to have a significant impact on further legislation addressing public education.

Upcoming March and April League meetings will be particularly interesting. In March, Bonnie Cox from the Jo Daviess League will discuss the new Mississippi River ILO. LWVGR joined this important Inter-League Organization in June, 2015 as we recognize the importance of a healthy

Mississippi watershed. Bonnie will discuss the goals of and impact the new ILO hopes to make as well as Mississippi watershed's significance to our lives. Please put March 8th on your calendar. In April, the Health Committee will put the results of the Winnebago Health Department's community survey in the spotlight. Please put April 12th on your calendar as a date not to be missed. More information will follow.

On the statewide level, our League continues to work with the Responsible Budget Coalition to end the budget impasse. With the spring session of the General Assembly set to begin soon and a FY 2016 budget that still needs to be passed, there will be requests from the state issues specialists for your help in advocating for League positions. The League needs your help more than ever to let our legislators and leaders know that the state of the state is not acceptable. A quick phone call or an email is all it takes.

The Board of Directors has been working to clarify League roles and put other helpful information into a handbook for new Board members, committee chairs, and for new League members. Although we set yearly program and goals, we felt clarification of duties would help the League function more smoothly, especially as new people move into leadership roles. It should be ready to share with you by the Annual Meeting.

Education Committee

The committee did not meet in February. The Education Committee presented the informational discussion on *Vision 20/20: Fulfilling the Promise of Public Education* at the February League meeting. Dr. Linda Oshita was our speaker. She presented a PowerPoint on the goals and promise of Vision 20/20 and answered audience questions. She also addressed the use of Title 1 funds, which has been contentious as the downstate districts must pay a surcharge on the hiring of special education teachers which goes towards pension debt. This is money that is supposed to go to districts with a high concentration of low income families to help close the achievement gap.

Illinois is one of the most regressive states in the country when it comes to funding our schools, depending heavily on local property taxes. Illinois ranks dead last when it comes to state funding support of schools. Currently, less than 27% of school funding comes from the state, down from a one time high of almost 49%. (As stated in the Illinois Constitution, the state is primarily responsible for funding education.) The result is the districts with the lowest property values which must depend on state funds often struggle to fund their schools compared to property-wealthy districts, which receive less state funding but have the property tax base to fully fund their schools.

There have been recent attempts to revamp the current school funding formula which have not passed or gotten lost in the noise of the budget impasse. Saying that Illinois' prosperity is tied to the success of its schools, Illinois Senate President John Cullerton has vowed to tie major legislation to school funding reform, much like the Governor's vow to tie the budget to his Turnaround Agenda. LWVIL and local Leagues will follow these developments closely and ask for your help in [reaching out to our legislators](#).

Although the League has successfully ensured the continuation of the LWVGR Scholarship Fund thanks to your generosity, our last general fundraiser to pay for educational materials and operating costs was in 2005. The Winnebago County Mental Health Committee will have the preliminary results of the Behavior Health Survey distributed in August 2015. The National Alliance of Mental Illness (NAMI) will be cosponsor with the LWVGR Health Committee presenting the program. We are expecting 200 people to attend and have rented both rooms at the YWCA. Dr. Sandra Martell, Winnebago County Public Health Administrator, will give the Introduction and Background of the Behavioral Health Survey followed by a three-member panel representing the Mental Health Advisory Committee Data Subcommittee, Mental Health Advisory Committee Funding Subcommittee and NAMI Consumer Overview Adult and pediatric perspective will give timed presentations. Our Deputy Registrars have been very busy taking registrations at ten area high schools, Rockford University, Rock Valley College, and four Schnuck's grocery stores. Thus far in this election year, we have taken 509 registrations, 430 in schools and 79 in stores. Many of those we registered are 17 year olds who will be able to vote in the March 15th Primary.

We also distributed 375 Election Guides to all of the area schools and answered countless questions about voter registration and the elections.

Our Deputy Registrars Alice Heath, Diane Cushing, Jane Kelley, Elsie Janson, Faye Marcus, Wanda Hoover, Maxine Hadley, Adrienne Langley, June Jacob, Glenda Shaver, and Teresa Hill gave freely of their time to help with our success.

Thank you to all of those who helped. This year we had a lot of help from teachers, principals and academy coaches who prepared students in advance which was extremely helpful. Thanks again also to Schnuck's for allowing us to set up in their stores.

Many of you have said that getting young people registered to vote is one of the most rewarding and fun jobs in the League. If anyone else would like to join us, we will be setting up classes after the March election. In April we will have another opportunity when we will be registering new citizens-another great experience. Our committee meets the first Thursday of each month at Mary's Market on MacFarland Rd at 8AM. Everyone is welcome to join us.

Phonathon 2016

LWVGR will participate in the state-wide effort to support LWVIL programs and activities by soliciting donations from our membership. LWVIL initiates the effort by mailing solicitation letters and the local leagues participate by making follow up calls at the Phonathon. Local leagues that participate in the Phonathon are eligible to receive a share of the donations made to LWVIL or to the LWVIL Education Fund.

The local League will participate in making calls during April, 2016, any donations received by LWVIL from members of your local League between December 1, 2015 and May 23, 2016 will be counted toward the total member support donations on which your share is based.

For 2016, the sharing percentage is 15%. For example, if members of your league contribute a total of \$300 to LWVIL between December 1, 2015 and May 23, 2016, your league would receive \$45.
